NAIST Education Policy

● Objectives

As a graduate institution without undergraduate courses, NAIST promotes cutting edge research and offers a sophisticated outcome-based education for each student so as to contribute to the advancement of science and technology and of society as a whole.

● Educational mission

NAIST was founded in October 1991 as a graduate institution which educates individuals who will contribute to the development of advanced science and technology. Research and education at NAIST covers the three core areas: information science, biological science and materials science.

In order to realize a suitable standard of living for people throughout the world in the 21st century, and indeed to secure our very survival, the coming generation of leading researchers must possess the highest scientific and technical competence, along with a clear grounding in professional ethics. At NAIST, we aim to cultivate such researchers and educators.

Therefore, in addition to the areas of information science, biological science and materials science, we actively encourage interdisciplinary research and provide educational training in the principles of ethics and intellectual property.

● Objectives for student development

Education and research in NAIST master's course cultivate sophisticated expertise and personal initiative to support society and the economy. The doctoral courses are designed to nurture students to become researchers and engineers with the drive to seek new frontiers in science and technology and to take on leading roles internationally.

● Educational policy

In addition to a specialized education, the wide-ranging curriculum cultivates ethical thinking, vision, theoretical thinking, comprehensive judgment and sharpened writing skills.

Educational programs to produce human resources who will pursue new interdisciplinary research fields are executed and those to produce human resources with a thorough, globally-focused understanding, which include collaborative programs with our overseas education and research partners, are offered.

Internal and external evaluations are implemented to continuously improve the quality of education, while enrichment of the education and research environments and the financial support for talented students are being promoted.

NAIST Admission Policy

- **Prospective students**

We are looking for students, researchers or engineers who have fundamental academic skills, a clear vision, a resolve toward the future, and a strong interest in and motivation for advanced science and technology, regardless of their background or undergraduate major. Especially, we actively accept applicants who have the ability to reason logically and accurately express their thoughts, and those who are very inquisitive and have the ability to tackle challenges.

- **Basic admissions policy**

In order to select outstanding persons with the above qualifications both domestically and abroad, we stress assessment of applicants' character and capability. There are various routes for admission, including examinations centered upon interviews as well as examinations based on recommendations.

2. Requirements for Application

Applicants who fulfill all of the following conditions can apply:

- (1) Those who do not hold Japanese nationality.
- (2) Those who are recommended by the president or dean of a university or research institution with which NAIST has concluded an Academic Exchange Agreement (see the URL below), and who are recognized for their excellence in academics, achievement, personality and character.

In accordance with the above, candidates must meet one of the criteria below:

A: Those who are registered as students, faculty members or researchers at the universities or research institution on the list.

B: Those who have graduated from a university or research institution on the list.

- (3) Regarding the bachelor's degree, applicants should meet one of the following conditions.

A: Those who have completed or will complete a 16-year curriculum of school education in foreign countries by March 31, 2022*.

B: Those who was conferred or will be conferred the equivalent of a bachelor's degree by March 31, 2022* by completing the course that the years required for graduation are 3 years or more in foreign university or other foreign schools deemed eligible by the Minister of MEXT.

C: Those who are recognized by NAIST through the Preliminary Screening for Suitability to have the academic ability equivalent or superior to the level of a bachelor's degree, and who will be 22 years of age or older by March 31, 2022*. (See Note)

Note : Applicants who wish to apply based on qualification (3)-C should follow the procedures given in item 7:
Preliminary Screening of Applicant Suitability on page 5 before taking the entrance examination.

*For Fall Admission these dates change to September 30, 2022.

(2) How to apply

- Please send all required documents by e-mail, postal mail or bring them directly to the address below.
When sending by e-mail, please scan all certificates and letter of recommendation required for application and send as attachments. Original certificates and letter of recommendation must be submitted at the time of enrollment.

- When applying by postal mail, application documents must arrive at NAIST by the last day of the application period, Japan time. Please send all application documents by registered express mail (DHL, FedEx, OCS or EMS, etc).
- * NAIST is not responsible for any loss of documents during the course of delivery.
- When bringing documents directly, please note that we accept application materials from 9:00 am to 5:00 pm during the application period (closed from 12:00 pm to 1:00 pm on weekdays).

(3) Notification of applicant's ID

Upon receiving application documents, we will notify you of your applicant's ID by e-mail.

(4) Examination fee

Examination fee is 30,000 yen.

A: Applicants living in Japan

Examination fee payment via bank transfer (by ATM etc.) is available.

Please contact the Admissions Section of the Educational Affairs Division [exam@ad.naist.jp] for the details.

B: Applicants living outside Japan

Overseas applicants must pay the examination fee via foreign remittance in yen according to the details specified in the table below. The total cost for foreign remittance is usually the local bank charge (stipulated by the sending bank), the MUFG Bank charge, and the 30,000 yen examination fee. Overseas applicants should consult with their local bank to verify that the amount credited to NAIST's MUFG Bank account (see below) **is 30,000 yen, and no less.** Overseas applicants must also submit a copy of the receipt of foreign remittance issued by the local remitting bank, or some other evidence of such bank transfer, together with the required application documents listed in 3. (5). Overseas applicants should keep the original receipt for their own records.

Important points

- Japanese government (Monbukagakusho: MEXT) scholarship students are exempt from the examination fee.
- Once the remittance is completed, please send an e-mail to the Admissions Section, Educational Affairs Division [exam@ad.naist.jp] with scanned copy of receipt as an attachment or the following information: Applicant's name, contact address and phone number, remittance amount, and amount of foreign remittance fee.
- If an overseas applicant's remittance is not completed by the deadline, the application may not be accepted. Once paid, the examination fee may not be refunded for any reason.

b	Graduation / Expected graduation certificate	Must be issued by a university or other educational institution. Applicants who meet Requirement for Application (3)-C (p.1) need not submit this certificate. If written in a language other than English, please attach an English translation.
c	Transcript	Must be issued by a university or other educational institution. Those who have approved transfer credits must also submit a transcript from the previous school (university, junior college, etc.). Applicants who meet Requirement for Application (3)-C (p.1) need not submit a transcript. If written in a language other than English, please attach an English translation.
d	Employment certificate	Only necessary for those who are employed as faculty members or researchers at the universities or research institution with which NAIST has concluded an Academic Exchange Agreement. Must be issued by a university or research institution. If written in a language other than English, please attach an English translation.
e	Letter of recommendation	Form provided by NAIST (issuing university/institution's form also accepted if it contains the same information). Must be issued by the president or dean (If the title is different from these, include an explanation of the position or homepage where this position is listed in English.) of a university or research institution with which NAIST has concluded an Academic Exchange Agreement. Must be in English.

g	Letter of Provisional Acceptance	<p>Form provided by NAIST.</p> <p>Must be issued by a professor of the examination category you are applying.</p> <p>Must be in English or Japanese.</p> <p>*1: Applicants must contact the professor whose lab they wish to join and obtain his/her preliminary approval of acceptance at least one month prior to the first day of the application period.</p> <p>*2: Before requesting a Letter of Provisional Acceptance, applicants should decide on the laboratory they wish to join. Applicants must not request Letters of Provisional Acceptance from more than one professor simultaneously.</p>

(6) Other notifications

- If the applicant has a physical disability and requires any special help in following the standard academic program, please consult with the Admissions Section of the Educational Affairs Division <e-mail: exam@ad.naist.jp> prior to applying.
- If the application documents are incomplete, the application will not be accepted in principle. Before submitting your application, make sure to check that all the necessary documents are enclosed or attached. Further changes to the submitted documents will not be accepted.
- You may be deemed to have committed a fraudulent act if you falsify, fabricate or plagiarize a document, materials or information included in your application. In such cases, any decisions made based upon the application and materials may be invalidated at a later date. If your entrance to NAIST is cancelled, your application, documents and examination fee may not be returned.

4. Screening Method

Applicants are evaluated according to a screening of application documents. However, an oral examination may be conducted in addition if deemed necessary. In that case, you will be notified separately of the date and place of the oral examination.

6. Payments Required for Admission

- (1) Enrollment fee: 282,000 yen (Provisional)
- (2) Tuition fee: 267,900 yen per semester. (535,800 yen for the annual fee) (Provisional)

If there is a change in fees, the new admission and tuition fees will apply to all students who will enter NAIST after the change.

7. Preliminary Screening of Applicant Suitability

Those who wish to apply under Requirement for Application (3)-C (p.1) must first pass the Preliminary Screening for Applicant Suitability before formally applying.

The result of the preliminary screening will be sent prior to the application period by e-mail.

8. Security Export Control
