

NAIST Education Policy

● Objectives

As a graduate institution without undergraduate courses, NAIST promotes cutting-edge research and offers a sophisticated outcome-based education for each student so as to contribute to the advancement of science and technology and of society as a whole.

● Educational mission

NAIST was founded in October 1991 as a graduate institution which educates individuals who will contribute to the development of advanced science and technology. Research and education at NAIST cover the three core areas: information science, biological science and materials science.

In order to realize a suitable standard of living for people throughout the world in the 21st century, and indeed to secure our very survival, the coming generation of leading researchers must possess the highest scientific and technical competence, along with a clear grounding in professional ethics. At NAIST, we aim to cultivate such researchers and educators.

Therefore, in addition to the areas of information science, biological science and materials science, we actively encourage interdisciplinary research and provide educational training in the principles of ethics and intellectual property.

● Objectives for student development

Education and research in NAIST master's course cultivate sophisticated expertise and personal initiative to support society and the economy. The doctoral courses are designed to nurture students to become researchers and engineers with the drive to seek new frontiers in science and technology and to take on leading roles internationally.

● Prospective students

We are looking for students, researchers or engineers who have fundamental academic skills, a clear vision, a resolve toward the future, and a strong interest in and motivation for advanced science and technology, regardless of their background or undergraduate major. Especially, we actively accept applicants who have the ability to reason logically and accurately express their thoughts, and those who are very inquisitive and have the ability to tackle challenges.

● Basic admissions policy

In order to select outstanding persons with the above qualifications both domestically and abroad, we stress assessment of applicants' character and capability. There are various routes for admission, including examinations centered upon interviews as well as examinations based on recommendations.

2. Eligibility for Application

- (1) Those who have graduated or will graduate from universities in Japan, as stipulated in Article 83-1 of the School Education Act, by March 31, 2027.
- (2) Those who hold, or will be conferred, a bachelor's degree by the National Institution for Academic Degrees and Quality Enhancement of Higher Education (Japan) by March 31, 2027, in accordance with Article 104-7, of the School Education Act.
- (3) Those who have completed, or will complete, a 16-year curriculum of school education in foreign countries by March 31, 2027.
- (4) Those who have completed, or will complete, a 16-year curriculum of foreign school education by taking a foreign school's correspondence course in Japan by March 31, 2027.
- (5) Those who have completed, or will complete, a 16-year curriculum by March 31, 2027 at a foreign educational institution in Japan that is authorized by the educational system of the foreign country and is specified or designated separately by the Minister of Education, Culture, Sports, Science and Technology (MEXT).
- (6) Those who hold, or will be conferred, the equivalent of a bachelor's degree by March 31, 2027 by completing a course of 3 years or more at a foreign university or other foreign educational institution. This includes cases where the course is completed by taking a foreign school's correspondence course, or at a foreign educational institution in Japan that is authorized by the educational system of the respective foreign country and is specified or designated by the Minister of Education, Culture, Sports, Science and Technology (MEXT). Eligible institutions are limited to those whose educational and research activities have been evaluated by an agency accredited by the respective foreign government or relevant organization, or those specified separately by the MEXT.
- (7) Those who have completed, or will complete by March 31, 2027, specialized courses at a vocational school specified by the Minister of Education, Culture, Sports, Science and Technology (MEXT), where the course period is 4 years or longer and meets the criteria specified by the MEXT.
- (8) Those who are deemed eligible or will be deemed eligible by March 31, 2027 by the Minister of Education, Culture, Sports, Science and Technology (MEXT) (Bulletin No.5, Ministry of Education, 1953).
- (9) Those who, by March 31, 2027, will have been enrolled in a university for 3 years or longer or those who will have completed a 15-year curriculum as described in (3), (4) or (5) with an excellent educational record in the designated courses. (*2., *3.)
- (10) Those who are recognized by NAIST, through Preliminary Screening of Applicant Suitability, to have an academic ability equivalent to a bachelor's degree and who will be 22 years of age by March 31, 2027. (*3.)

*1. The date for applicants for Fall Admission is September 30, 2027, specified in the "Eligibility for Application (1), (2), (3), (4), (5), (6), (7), (8), (9), (10) above.

*2. "Designated Courses" for Eligibility for Application (9): In principle, this refers to the number of credits required for graduation that will be completed by the end of the applicant's third year in their current department. These include credits for general education subjects (such as humanities, social sciences, natural sciences, foreign languages, and health and physical education) as well as credits for specialized courses. Those who enrolled at NAIST under this eligibility will be regarded as having withdrawn from the student register of their current

university and will not be eligible to take the national examinations that require graduation from a university as a prerequisite.

*3. Applicants who wish to apply based on Eligibility for Application (9) or (10) should follow the procedures given in **Article 10: Preliminary Screening of Applicant Suitability (for applicants who meet eligibility requirements (9) and (10))** on page 12 before taking the entrance examination.

7. Method of Examination

(1) Method of Examination

<For all applicants>

- The examination will consist of a 20 minute interview in Japanese or English, depending on the language selected at the time of application registration.
- In principle, interviews are conducted remotely using an online conferencing system.
- Please refer to the Online Application System for details on the technical conditions required for the online interview: <https://e-apply.jp/ds/naist/>

*If the number of applicants reaches twice the number of admission capacity specified for a given field of study,

a preliminary screening may be conducted based on the submitted documents. In such cases, only those who pass the preliminary screening will be eligible to take the interview examination. Please note that the examination fee will not be refunded to applicants who do not pass the preliminary screening.

Information Science

- (i) Oral examination on questions of mathematics (algebra, analysis, etc.)
- (ii) Questions regarding the research proposal and areas of information science relevant to the examinee's area of specialization.

Make sure that no materials are in sight during the interview.

[Scope of mathematics questions]

Algebra: From Chapter 1 to Chapter 7 of the following book.

Gilbert Strang, Introduction to Linear Algebra, Fourth edition, Wellesley-Cambridge Press.

Analysis: From Chapter 1 to Chapter 15 of the following book.

Serge Lang, A First Course in Calculus, Fifth edition Springer.

Biological Science

- (i) A 5-minute oral presentation on the examinee's research proposal.
- (ii) Oral examination based on the research proposal and oral presentation.

No materials may be in sight except for examinee's own research proposal.

[Scope of biological science questions]

Basic knowledge related to the examinee's field of study and research plan at NAIST.

Materials Science

- (i) A 5-minute oral presentation on their research proposal.
- (ii) A 15-minute oral examination related to materials science will be conducted, based on the submitted research proposal and the examinee's area of specialization.

No materials may be in sight except for the examinee's own research proposal. Figures or charts in research proposals may be used or explained.

[Scope of materials science questions]

Basic knowledge of materials science relevant to examinee's area of specialization.

(2) Evaluation criteria

In the interview, basic academic ability, enthusiasm for research, and potential as a researcher will be evaluated comprehensively.

(3) Acceptance criteria

Successful applicants will be decided on the basis of an overall evaluation of interview results, the research proposal, school transcripts, TOEIC / TOEFL / IELTS / Duolingo English Test scores, as well as awards and other activities.

(4) Examination period and location

- NAIST will designate your examination date within the period specified below.
- Applicants will have a preliminary connection test prior to the examination date indicated as follows.

* Applicants who meet Eligibility for Application (9)

Applicants who pass the examination but fall under Eligibility for Application (9), and are therefore required to complete the prescribed credits with excellent results by the end of their third year, will be designated as “provisional passers” on the date of the examination results announced.

“Provisional passers” are required to submit transcripts covering their first three years of undergraduate studies by 4:00 pm on March 15 (Mon), 2027. If the transcripts meet the stipulated conditions, these students will be officially recognized as successful applicants on March 17 (Wed), 2027. In this case, the enrollment period take place in late March, 2027.

If Applicants for Fall admission cannot submit transcripts covering their first three years of undergraduate studies by 4:00 pm on March 15 (Mon), 2027, they must submit their transcripts by the mid-September, 2027. After confirming through transcripts that the applicant meets the eligibility requirements, official notification of acceptance will be issued in mid-September 2027. In this case, the enrollment procedure period is in late September, 2027.

9. Payments Required for Admission

(1) Admission fee: 282,000 yen (Provisional)
(2) Tuition fee: 267,900 yen per semester 2027 (535,800 yen for the annual fee) (Provisional)

- If there is a change in fees, the new admission and tuition fees will apply to all payments following the change.
- Tuition for the spring and fall terms can be paid together upon request.

The results of the eligibility screening will be sent by e-mail to the address used to request the forms required for the application, by the end of the application period.

11. Long-Term Completion System

The Long-Term Completion System is designed for students who have difficulty completing their graduate courses within the standard allotted period due to employment or other circumstances. This System allows students to extend their study plan beyond the standard period, enabling them to complete their courses in a planned and flexible manner. If approved by the university, students may remain enrolled beyond two years while paying tuition equivalent to two years.

The annual tuition fee is calculated by dividing the total fee for two years by the number of years approved for the extended study period. However, if there is a tuition fee revision during enrollment, the revised fee will apply from the time of the revision.
