# Objectives

As a graduate institution without undergraduate courses, NAIST promotes cutting edge research and offers a sophisticated outcome-based education for each student so as to contribute to the advancement of science and technology and of society as a whole.

Especially, we actively accept applicants who have the ability to reason logically and accurately express their thoughts, and those who are very inquisitive and have the ability to tackle challenges.

# Basic admissions policy

In order to select outstanding persons with the above qualifications both domestically and abroad, we stress assessment of applicants' character and capability. There are various routes for admission, including examinations centered upon interviews as well as examinations based on recommendations.

# 2. Qualifications for Application

- (1) Those who have graduated or will graduate from universities in Japan stipulated in the School Education Act, Article 83-1 by September 30, 2021.
- (2) Those who hold or will be conferred a bachelor's degree from the National Institution for Academic Degrees and Quality Enhancement of Higher Education (Japan) by September 30, 2021 in accordance with the School Education Act, Article 104-7.
- (3) Those who have completed or will complete a 16-year curriculum of school education in foreign countries by September 30, 2021.
- (4) Those who have completed or will complete a 16-year curriculum of foreign school education by taking a foreign school's correspondence course in Japan by September 30, 2021.
- (5) Those who have completed or will complete a 16-year curriculum by September 30, 2021 at a foreign educational institute in Japan which is authorized by the educational system of the foreign country and specified separately by the Minister of MEXT.
- (6) Those who hold or will be conferred the equivalent of a bachelor's degree by September 30, 2021 by completing a course of 3 years or more (including cases where the course is completed by taking a foreign school's correspondence course or completed at a foreign educational institute in Japan which is authorized by the educational system of the foreign country and specified by the Minister of MEXT) at a foreign university or other foreign educational institute (limited to those institutions whose educational and research activities have been evaluated by the agency accredited by the foreign government or the organization concerned, or those specified separately by the Minister of MEXT).
- (7) Those who have completed or will complete specialized courses (the course period must be 4 years or longer and the course must meet the criteria specified by the Minister of MEXT) by September 30, 2021 at a vocational school designated by the Minister of MEXT.
- (8) Those who are deemed eligible or will be deemed eligible by September 30, 2021 by the Minister of MEXT (Bulletin No.5, Ministry of Education, 1953).
- (9) Those who will have been enrolled in a university for 3 years or longer as of September 30, 2021, or who will complete a 15-year curriculum as specified in (3), (4) or (5) with an excellent educational record in the designated courses. (\*1., \*2.)
- (10) Those who are recognized by NAIST through Preliminary Screening of Applicant Suitability to have an academic ability at the level of a bachelor's degree and who will be 22 years of age by September 30, 2021.(\*2.)

<sup>\*1. &</sup>quot;Designated courses" for qualification (9): In principle, this refers to the number of credits required for graduation that will be completed by the end of applicant's junior year in their current department (credits for general education such as humanities, social sciences, natural sciences, foreign languages, and health and physical education, and credits for specialized courses). Those who are enrolled at NAIST based on this qualification are regarded as being withdrawn from their current university register, and will not be eligible to take the national examinations that specify graduation from a university as a prerequisite.

<sup>\*2.</sup> Applicants who wish to apply based on qualification (9) or (10) should follow the procedures given in **Article 7: Preliminary Screening of Applicant Suitability (for applicants who meet qualification (9) and (10))** on page 9 before taking the entrance examination.

#### B: Applicants living outside Japan

# 4. Method of Examination

#### (1) Method of Examination

<For all applicants>

- The examination will consist of a 20 minute interview in Japanese or English (applicants select the language in "Application Form")
- Applicants for 1st examination or 2nd examination select where their preferred examination location from 3 options, at NAIST, online\*, or no preference. However, due to facility restrictions,, we may not be able to meet your request.
- Whether the examinations is taken at NAIST or online, there are no differences in examination contents, evaluation criteria, and acceptance criteria.

## information science

- (i) Oral examination on questions of mathematics (algebra, analysis, etc)
- (ii) Questions regarding the research proposal and areas of information science relevant to the examinees' area of specialization.

Make sure that no materials are in sight during the interview.

## biological science

- (i) A 3-minute presentation.
- (ii) Oral examination regarding the specialized knowledge in connection with examinees' own research proposal.

Examinees are asked about the basic knowledge, comprehension, and explanatory ability of the field described in research proposal.

(iii) Oral examination based on research proposal, especially about research plan at NAIST..

Make sure that no materials are in sight during the interview.

[Scope of biological science questions]

Oral examination based on research proposal, especially about research plan at NAIST.

## materials science

- (i) A 5-minute presentation on their research proposal.
- (ii) Questions concerning the research proposal, relevant to examinees' area of specialization and to materials science in general for about 15 minutes.

No materials may be in sight except for examinees' own research proposal. Figures or charts in research proposals may be used or explained.

[Scope of materials science questions]

Basic knowledge of materials science relevant to examinees' area of specialization.

#### (2) Evaluation criteria

In the interview, basic academic ability, enthusiasm, and potential as a researcher will be evaluated comprehensively.

#### (3) Acceptance criteria

Successful applicants will be decided on the basis of an overall evaluation of interview results, the research proposal, school transcripts and TOEIC / TOEFL / IELTS / Duolingo English Test scores.

#### (4) Examination period and location

- NAIST will designate your examination date within the period specified below.
- Applicants who take the examination online will have a preliminary connection test about one week prior to the
  examination date. Notification for the preliminary connection test date will be included with your examination
  voucher.
- · If there are dates you are not able to attend the examination, please state the date(s) and the reason(s) in the

Applicants who pass the examination but who meet qualification (9) and are therefore required to have completed the necessary credits with excellent results by the end of the junior year will be regarded as "provisional passers" of the examination on the date of announcing the examination results.

"Provisional passers" are required to submit transcripts which cover their first three years of undergraduate studies by middle of September, 2021. If the transcripts meet the stipulated conditions, those students are officially regarded on middle of September, 2021 as successful applicants.

## 6. Payments Required for Admission

- (1) Admission fee: 282,000 yen (Provisional)
- (2) Tuition fee: 267,900 yen for the Fall 2021 term (535,800 yen annually) (Provisional)
- If there is a change in fees, the new admission and tuition fees will apply to all payments following the change.

# 8. Long-Term Completion System

The Long-Term Completion System is a system for students who have difficulty completing their graduate courses within the standard allotted period due to employment responsibilities or other reasons. The System aims to aid students in creating their study plan over the standard period and ensure they finish their courses.

Students in master's courses may extend their periods of study for one or two years. These extensions will enable students to receive degrees in accordance with their plans.

When newly enrolled students apply for this system, the total tuition fee for the standard period will be divided into the number of the years permitted by NAIST.
